WESTMORELAND COUNTY INDUSTRIAL DEVELOPMENT CORPORATION

A meeting of the Westmoreland County Industrial Development Corporation was held on Thursday, October 21, 2021 at the Westmoreland County Courthouse, Commissioners Public Meeting Rooms, 2 North Main Street Greensburg, PA. The following were present: Commissioner Sean Kertes, Commissioner Douglas W. Chew, Commissioner Gina Cerilli Thrasher, Esq. and Executive Director Jason Rigone. The following business was conducted:

Mr. Kertes called the meeting to order at 10:10am

Motion was made by Mr. Chew, seconded by Mrs. Cerilli Thrasher and it was unanimously agreed to approve the minutes of regular meeting held Thursday, September 30, 2021 as presented

Upon review and recommendation of Jason Rigone, Executive Director, motion was made by Mr. Chew, seconded by Mrs. Cerilli Thrasher and it was unanimously agreed to approve the following:

- (1) Oil and Gas Lease and associated documents with **Olympus Energy LLC**. for approximately 377 acres at the Westmoreland Business and Research Park property located in Washington and Upper Burrell Townships.
- (2) Proposal from **Triad Engineering, Inc.** in the amount of \$3,750.00 for the Westmoreland Airpark located in Unity Township. This agreement is to provide general consulting services to review PennDOT related design documents for the Laurel Valley Transportation Improvement Project as it relates to the Airpark property. The consulting services will include a review of potential impacts to utilities, roadways, permitting and the development potential of existing lots.
- (3) Fourth Addendum to **Southwestern Pennsylvania Commission** (**SPC**), Contract 19-12(i) for the ENGAGE! Program which supports the efforts of a statewide business retention and expansion program designed to regularly and proactively interact with targeted companies. The Addendum will extend SPC's current contract by twelve (12) months with effective dates of July 1, 2021 thru June 30, 2022 for \$14,400. SPC will continue to pay the WCIDC for eligible project costs incurred under this agreement, subject to the availability of state funds, in accordance and in compliance with the Commonwealth of Pennsylvania, Department of Community and Economic Development, ENGAGE! Program Grant Contract C000072193.
- (4) Award a Bid with **ArTECH Group, LLC** in the amount of \$277,700.00 for South Greensburg Commons Entrance Stairs & Ramp Project for Westside Entrance A and Westside Entrance B located in the City of South Greensburg. Other bids received:
