<b><u>Incident Details:</u></b> <ul style="list-style-type: none"><li>▪ Westmoreland County Coroner, Kenneth A. Bacha, has released the following information on a motor vehicle collision with two fatalities that occurred in Hempfield Township.</li><li>▪ Marc F. Delissio was the operator and Kirstin R. Kerrigan was a passenger of a 2018, Dodge Charger, traveling west on Baughman Hollow Road.</li><li>▪ For an unknown reason, the vehicle crossed the center line into the opposite lane of travel, left the south side of the roadway, struck multiple large trees, and overturned.</li><li>▪ Deputy Coroner Jonathon Jenkins pronounced Marc F. Delissio dead at the scene.</li><li>▪ Kirstin R. Kerrigan was transported by emergency medical personnel to Excelsa Westmoreland Emergency Department where she was pronounced dead by a hospital physician.</li><li>▪ A seat-belt was utilized by Marc F. Delissio.</li><li>▪ A seat-belt was not utilized by Kirstin R. Kerrigan.</li><li>▪ Air bags did deploy within the vehicle.</li><li>▪ Cell phone use being a factor in the incident is unknown at this time.</li><li>▪ The cause and manner of death for both decedents is reflected above.</li><li>▪ Toxicology results will not be available for several weeks.</li><li>▪ A funeral home has not been chosen at this time for Marc F. Delissio.</li><li>▪ Snyder Funeral Home of Irwin will be in charge of arrangements for Kirstin R. Kerrigan.</li><li>▪ Pennsylvania State Police Greensburg Barracks also investigated the incident.</li></ul>
