WHEREAS, the Federal Motor Carrier Satety Administration (FMCSA) Commercial Driver's License Drug and Alcohol Clearinghouse (Clearinghouse) went into effect earlier this year; and

WHEREAS, the Clearinghouse Rule requires FMSCSA regulated employers, such as Westmoreland County (County), to report to the Clearinghouse information related to violations of drug and alcohol regulations of CDL drivers; and

WHEREAS an employer, such as the County, is required to register in the Clearinghouse; to use the Clearinghouse to report drug and alcohol violations of its CDL drivers ("driver" or "drivers"); to conduct a full query as part of each preemployment driver investigation process; to conduct limited queries at least annually for every driver the County employs; to request electronic consent from the driver for a full query; and to record the negative return-to-duty test results and the date of successful completion of a follow-up testing plan for any driver the County employs with unresolved drug and alcohol program violations; and

WHEREAS, the County is permitted to designate a Consortium to manage its drug and alcohol testing program for the County's drivers; and

WHEREAS, Three Rivers Lab Testing, LLC d/b/a Arcpoint Labs of Pittsburgh North, is willing to serve as the County's Clearinghouse Consortium and to perform consortium services, consisting of annual partial queries and full queries as required, Clearinghouse entry for positive BAT results and SAP follow-up negative results, DOT Random Pool and Ordering Platform and MIS Reporting; and

WHEREAS, Three Rivers is willing to perform consortium services as well as drug and alcohol testing at the following rates: DOT Urine Drug Screen (\$59.00 per test); Breath Alcohol (\$49.00 per test); Consortium (\$350.00 annual fee); After hours, On-Site Fee and all Post-Accident (\$250.00); and On-Site Hourly Fee (\$75.00 per hour plus mileage) for the period of February 13, 2020 to July 31, 2020 at a cost not to exceed \$10,000.00.

RESOLUTION #R-3-2020

WHEREAS, at the beginning of February, 2020, it was discovered that the circuits and conduits in the lighting in the exterior front parking lot of the Westmoreland County Prison needed replaced as a result of damage to the wiring; and

WHEREAS, Westmoreland County Prison houses approximately 600 inmates and approximately 200 employees, as well as the administrative offices for personnel who oversee the operations of Westmoreland County Prison; and

WHEREAS, the Westmoreland County Prison is visited frequently by the general public and is a secure facility, causing it to be imperative to have functional lighting in the parking lot; and

WHEREAS, the Warden of Westmoreland County Prison has informed the Board of County Commissioners that replacement and repair of the circuits and conduits in the lighting is necessary for the safety and security of the Westmoreland County Prison; and

WHEREAS, to prepare written specifications, advertise for sealed written bids in a newspaper of general circulation, review the bids submitted, evaluate the qualifications of the prospective vendors, award a contract to the lowest responsible and responsive bidder, prepare and obtain signed contracts, order the necessary parts and equipment and carry out the repairs would require a period of four to eight weeks, during which time the safety and security of the Westmoreland County Prison is at risk; and

WHEREAS, Turik's Electric, is willing to provide the parts, travel time, mileage and labor including the following:

- Replacement of circuits and conduits as a result of damage to wiring in the exterior front parking lot lighting and additional work as required.
- Install two new parallel EMT conduits for interior, and schedule 80 PVC conduits for exterior.

 - The second lighting feed will consist of #10-3 wire single phase 208Volt from interior lighting panel to exterior bollard lights.

WHEREAS, the Warden of Westmoreland County Prison has informed the Board of County Commissioners that replacement and repair of the water heater tank is necessary given that the water heater tank is more likely to fail catastrophically at any time, causing the facility to have diminished hot water capacity and making it imperative to take immediate steps to replace the water heater tank; and

WHEREAS, to prepare written specifications, advertise for sealed written bids in a newspaper of general circulation, review the bids submitted, evaluate the qualifications of the prospective vendors, award a contract to the lowest responsible and responsive bidder, prepare and obtain signed contracts, order the necessary parts and equipment and carry out the repairs would require a period of four to eight weeks, during which time the safety of the Westmoreland County Prison is at risk; and

WHEREAS, MPS (McCarl's Preferred Services), is willing to provide the parts, travel time, mileage and labor including the following:

- Disconnect domestic water supply, return and drain lines from existing tank;
- Remove existing water heater tank;
- Install one Durapek PS-1392-GG Water Heater Tank;
- Connect the domestic water lines to the new tank via pro press fittings and valves;
- Connect the steam supply and condensate lines to the new tank steam bundle;
- Install new bronze circulating pump;
- Install new relief valve;
- Fill new tank and purge air from sytem;
- Open steam lines and check system for proper operation; and
- Insulate exposed pipes associated with the replacement tank only.

WHEREAS, the price includes all parts, travel time, mileage and labor, but the price for all of the said work will exceed the statutory threshold for awarding contracts without advertising for sealed written bids; and

WHEREAS, Section 1802(b) of the County Code [16 P.S. §1802(b)] allows contracts in excess of the statutory bid threshold to be awarded without the usual advertisement requirements of the County Code in case of emergency, if such emergency is declared and stated by resolution of the Board of County Commissioners.

 - Disconnect domestic water supply, return and drain lines from existing tank;
 - Remove existing water heater tank;
 - Install one Durapek PS-1392-GG Water Heater Tank;
 - Connect the domestic water lines to the new tank via pro press fittings and valves;
 - Connect the steam supply and condensate lines to the new tank steam bundle;
 - Install new bronze circulating pump;

RESOLUTION #R-6-2020

WHEREAS, Westmoreland Manor houses the County's skilled nursing facility, including physical therapy, occupational therapy, speech therapy, IV therapy, and respiratory therapy services; hospice and respite care services; and

WHEREAS, on January 24, 2020, the Pennsylvania Department of Health notified the County of a potential issue at Westmoreland Manor with its water source, namely Legionella.

WHEREAS, the Pennsylvania Department of Health further informed the County that it should implement remediation measures, including prevention measures and water distribution system control measures in the form of either thermal eradication or shock chlorination; and

WHEREAS, the County took immediate precautions, including prohibiting consumption of the water and implementing bed baths instead of showering/whirlpool bathing; and

WHEREAS, the County began remediation efforts in the form of thermal eradication; and

WHEREAS, due to the inability to maintain the required water temperature for thermal eradication, the County is required to begin remediation efforts in the form of shock chlorination; and

WHEREAS, to prepare written specifications, advertise for sealed written bids in a newspaper of general circulation, review the bids submitted, evaluate the qualifications of the prospective vendors, award a contract to the lowest responsible and responsive bidder, and prepare and obtain signed contracts, would require a period of four to eight weeks, during which time the Manor would continue to be under precautions and would not have undertaken the remediation measures required by the Pennsylvania Department of Health, posing a threat to the residents of Westmoreland Manor; and

WHEREAS, Section 1802(b) of the County Code provides for emergency situations without the usual advertisement requirements of the County Code, if such emergency is declared and stated by resolution of the Board of County Commissioners; and

WHEREAS, the Manor has contacted a number of vendors, including Suez, Chemway, Klenzoid, Cyprus Rice Water, Innovative Water Consulting, GLA Water Consultants, Inc. and Garratt Callahan, but a number of vendors are unable to begin the work immediately;

WHEREAS, due to the urgency of the matter, the County has received proposals from both GLA Water Consultants, Inc. in the amount of \$23,950.00 and from Garratt Callahan, in the total amount of \$16,730.00 (shock chlorination (disinfection of potable hot water system) in the amount of \$14,600.00, along with related chemicals needed for the shock chlorination in the amount of \$2,130.00). and

WHEREAS, Garratt Callahan, is willing to provide the necessary labor, materials and equipment necessary to perform the shock chlorination.

NOW, THEREFORE, it is resolved by the Board of Commissioners of the County of Westmoreland, Pennsylvania, that:

- 1. The Board of Commissioners has determined that immediate action must be taken at Westmoreland Manor to address the Legionella in its water supply by implementing shock chlorination.
- 2. The Board of Commissioners has further determined that it will require a time period of at least four weeks, and possibly as long as eight or more weeks, to prepare written specifications for the shock chlorination, and to advertise for sealed written bids in a newspaper of general circulation, review the bids submitted, evaluate the qualifications of the prospective vendors, award a contract to the lowest responsible and responsive bidder, prepare and obtain signed contracts, and authorize the successful bidder to proceed with the contracted work.
- 3. The Board finds that the substantial risk of physical harm to the elderly and physically fragile residents of the skilled nursing facility at Westmoreland Manor and the mandate of the Pennsylvania Department of Health to begin remediation constitute an actual emergency that justifies accepting the proposal of Garratt Callahan to provide remediation services in the form of shock chlorination (disinfection of potable hot water system, in the amount of \$14,600.00, along with related chemicals needed for the shock chlorination in the amount of \$2,130.00) without first advertising for bids.

RESOLVED and enacted this 13th day of February, 2020.
