Bacha, has released the following information on a residential structure fire in Rostraver Township.</li><li>▪ Neighbors contacted 911, due to the decedent's residence being on fire.</li><li>▪ Firefighters arrived on scene finding the residence to be fully involved.</li><li>▪ The decedents were discovered within the residence.</li><li>▪ Deputy Coroner Joshua C. Zappone pronounced both decedents dead at the scene.</li><li>▪ An autopsy is scheduled with Dr. Cyril H. Wecht and Pathology Associates on July 12, 2020.</li><li>▪ Cause and manner of death will be pending autopsy results, toxicology results, and further investigation into the cause of the fire.</li><li>▪ Toxicology results will not be available for several weeks.</li><li>▪ McCauley Funeral Home of West Newton will be in charge of arrangements for both decedents.</li><li>▪ Rostraver Township Police and the Pennsylvania State Police Fire Marshal also investigated.</li></ul> <p style="text-align: center;"><b>****<u>No further information is available at this time</u>****</b></p>
