<u>Incident Details:</u> <ul style="list-style-type: none">▪ Westmoreland County Coroner, Kenneth A. Bacha, has released the following information on a two-vehicle collision that resulted in multiple fatalities.▪ Jeffrey J. Tomay was the passenger of a Buick LeSabre traveling west on U.S. 30.▪ Thu Thi Xuan Nguyen was the operator of a Honda CRV traveling east on U.S. 30.▪ The Buick LeSabre crossed the centerline into the opposite lane of travel and struck the Honda CRV in a head-on type collision.▪ Deputy Coroner John A. Ackerman pronounced Jeffrey J. Tomay and Thu Thi Xuan Nguyen dead at the scene.▪ Two other individuals involved in the incident were transported to an Allegheny County hospital where they were pronounced dead.▪ A seat-belt was not utilized by Jeffrey J. Tomay.▪ A seat-belt was utilized by Thu Thi Xuan Nguyen.▪ Cell phone use being a factor in the incident is unknown at this time.▪ The cause and manner of death for both decedents is reflected above.▪ Toxicology results will not be available for several weeks.▪ Beatty-Rich Funeral Home of Madison will be in charge of arrangements for Jeffrey J. Tomay.▪ Barnhart Funeral Home of Greensburg will be in charge of arrangement for Thu Thi Xuan Nguyen.▪ North Huntingdon Township Police also investigated the incident and will release additional details at their discretion.
