Incident Details

- Westmoreland County Coroner, Timothy Carson, has released the following information on a single motorcycle collision that resulted in multiple fatalities.
- Timothy P. Kuhns was the operator of a 2004 Harley Davidson Sportster Motorcycle traveling North on State Route 819.
- Jennifer L. Ramsey was the passenger of the Harley Davidson Sportster Motorcycle.
- The decedent failed to negotiate a curve in the roadway causing his motorcycle to travel off the roadway.
- The decedent lost control of his motorcycle, at which time both decedents became separated from the motorcycle.
- Deputy Coroner, Russell A. Morgan, pronounced Timothy P. Kuhns and Jennifer L. Ramsey dead at the scene.
- A helmet was not utilized by Timothy P. Kuhns or Jennifer L. Ramsey.
- It appears speed was a factor in the collision.
- It is unknown if drugs or cellular telephone use were a factor in the collision at this time.
- The cause and manner of death for both decedents is reflected above.
- Toxicology results will not be available for several weeks.
- A Funeral Home is unknown at this time for Timothy P. Kuhns or Jennifer L. Ramsey.
- Pennsylvania State Police-Greensburg also investigated the incident and will release additional details at their discretion.
