Certificates must be in the amount of **\$1 million** with **Westmoreland County, their officers and employees are named as additional insureds** in the Description of Operations; no exceptions will be made. A new certificate must be presented for each event date. Please call the office for questions/concerns 724-830-3952.
- Walk-a-Thons, Bike-a-Thons, Dog Shows or any other major public event require a **Special Event Application**. **These events are subject to approval**. Please contact the office at 724-830-3952 to secure an application.

Equipment must be returned in the box provided at your pavilion, or if you are renting a pavilion with a kitchen, must be left in the kitchen at the end of the day.
