The Westmoreland County Office of the Coroner extends its deepest sympathy during this difficult time. It is our hope that the information contained in this Survivors' Guide will assist your decision making and provide helpful solutions during this time of loss.

Coroner's Office Jurisdiction

The Coroner's Office is mandated by the Commonwealth of Pennsylvania to investigate and determine the manner and cause of death. These include cases of homicide, suicide, accidental, and all natural deaths that are sudden, unexpected, or medically unattended. Accordingly, the manner and cause of death are determined by means of investigation, toxicology, and an extensive postmortem examination (autopsy), at which time a death certificate is generated in accordance with the medical findings.

The postmortem examination (autopsy) is vital in the determination of a definitive manner and cause of death. The final autopsy decision is made by the Forensic Pathologist. Autopsy objections from the next of kin are considered only after an autopsy waiver is signed. Please be advised that the autopsy waiver in itself does not preclude the autopsy. Without this critical and often necessary procedure, it is more difficult for the Coroner's Office to accurately determine a manner and cause of death.

Disposition of Remains

The Office of the Coroner is located at 2503 South Grande Boulevard in Greensburg, PA. If a positive identification is necessary, an investigator will notify the next of kin in conjunction with the police department, at which time the procedure will be explained regarding identification of the decedent. The Coroner's Office will provide viewing of the deceased only in cases where a positive identification is absolutely necessary. The office is not designed as a viewing facility.

Organ Donation

Although facing the death of a loved one is overwhelming, a decision regarding organ donation may present the opportunity to save lives. Once it is determined that your loved one has no medical condition that would medically preclude the organ donation, a representative from the Center of Organ Recovery and Education (C.O.R.E.) will advise and discuss your options. The organ donation procedure will not be performed without the authorization of both the next of kin and the Coroner's Office.

Release of Decedent & Personal Effects

At the earliest convenience, it is advised that the legal next of kin select a funeral home and inform the funeral director that the death is under the jurisdiction of the Coroner's Office. Generally, the release of the decedent should not take more than 24 hours. The funeral director will coordinate the release on your behalf.

The Office of the Coroner does not select, recommend, or make funeral arrangements. In the event someone is making funeral arrangements for the family, the Coroner must be provided with written authorization to release the deceased, which should be signed by the next of kin.

Personal possessions in the custody of the Coroner's Office may be claimed by the legal next of kin. To avoid any inconvenience, call the office and schedule an appointment. Photo identification is required prior to the release of personal effects.

Unless there is a need to hold clothing as evidence, it is released to the funeral director recovering the deceased. Clothing that presents a health hazard may be disposed of for the safety of all persons involved.

Death Certificates

Once the determination is made regarding the manner and cause of death, a certificate is generated to the responsible Funeral Home. The original certificate is filed with the Pennsylvania Division of Vital Records by the Funeral Director. Certified Copies of this certificate can be obtained from the Funeral Director or the Division of Vital Records at a minimal cost.

Copies of Reports

Final autopsy, toxicology, and investigation reports are available for release ONLY to the legal next of kin. The Coroner's Office requires written permission from the next of kin prior to the release of all reports. There is no charge for the initial copy of the reports to the legal next of kin. The fees for all additional copies for legal, insurance, and other reasons are as follows:

Autopsy	\$100.00
Toxicology	\$50.00
Investigation	\$50.00

*Payment for all reports must be made in advance.

Non-Availability of Funds for Disposition

Westmoreland County does not provide an indigent burial program. In the event the deceased or the legal next of kin does not have sufficient funds for disposition, organizations such as various medical research organizations, may provide assistance, options, and recommendations regarding disposition if funding is not attainable.

Veterans Affairs

The Westmoreland County Office of Veterans Affairs and the U.S. Department of Veterans Affairs are resources the next of kin of a deceased veteran may use to request military records for the purpose of determining if the decedent is eligible for a Veteran's burial.
