# Rules For Promotional Booths

1. A 10' x 10' tent, table and chairs will be provided to you at no additional cost. You may bring your own tent and supplies if you so desire.
2. **NO SALES** may be conducted at the booth. The operation at the booth must be strictly promotional in nature.
3. **NO BARKING.** Advertising within the park via signs, barking, or by any other means other than signage placed within and around the booth itself is not permitted. Do not block pedestrian walkways; please stay within your 10' x 10' area.
4. A limited number of applications will be accepted at each event. The committee will review all applications and those not accepted will receive a full refund of all fees sent.
5. The fee schedule is listed below on the application. Non-profit corporation fees will be discounted by \$50 per event. For-profits can attend all three events for **\$500**; Non-profits can attend all three events for **\$400**.
